1. PAYMENT

- (a) is to be by cash, cheque, bank cheque or Electronic Funds Transfer without deduction within **30 days** from the end of each months trading.
- (b) ROCK SOLID GARDENING SUPPLIES PTY LTD reserves the right to recover, from the purchaser, all costs incurred in collection of overdue and outstanding accounts.

2. LIMIT OF LIABILITY:

- (a) The Customer agrees to limit any claim it makes to the cost of re-supply of equivalent products or the supply of services again.
- (b) ROCK SOLID GARDENING SUPPLIES PTY LTD shall not be liable for any claim, loss or expense arising which is made after 30 days from date of delivery of product or services (or at all once products have been on-sold or otherwise used or applied) after which there shall be deemed to have been unqualified acceptance.
- (c) ROCK SOLID GARDENING SUPPLIES PTY LTD will not be liable in any way for any contingent, consequential direct or indirect special or punitive damage arising in any way and whether due to negligence or otherwise and the Customer acknowledges this express limit of liability and agrees to limit any claim accordingly.
- (d) No other term, condition, agreement, warranty, representation or understanding whatsoever whether express or implied in any way extending to, otherwise relating to or binding upon ROCK SOLID GARDENING SUPPLIES PTY LTD other than these Terms, is made or given.

3. EXCLUSIONS:

Any advice or assistance given for or on behalf of ROCK SOLID GARDENING SUPPLIES PTY LTD shall be accepted at the Customer’s risk and shall not be or be deemed given as expert or adviser nor to have been relied upon by the Customer.

4. PLACEMENT OF ORDERS:

- (a) In the event of any dispute arising over any order (and including any question of identity or authority or any telephone, facsimile, computer or e-mail order), the internal records of ROCK SOLID GARDENING SUPPLIES PTY LTD will be conclusive evidence of what was ordered in all respects.
- (b) Each order placed shall be and be deemed to be a representation made by the Customer at the time that it is solvent and able to pay all of its debts as and when they fall due.
- (c) Failure to pay in accordance with these Terms shall be and be deemed to be conclusive evidence that the Customer had no reasonable grounds for making the representation and the representations were unconscionable, misleading and deceptive.
- (d) When any order is placed, the Customer shall inform ROCK SOLID GARDENING SUPPLIES PTY LTD of any material facts which would or might reasonable affect any decision to accept the order and or grant credit in relation thereto and any failure to do so shall create and be deemed to create an inequality of bargaining position, shall constitute the taking of an unfair advantage of ROCK SOLID GARDENING SUPPLIES PTY LTD and to be unconscionable, misleading and deceptive.

9. CUSTOMER RESTRUCTURE:
